D) Must have made 6 prior consecutive monthly payments. E) Restrictions may apply to Loans with GAP. Members can only skip one month's payment per loan. Commercial loans are not eligible to participate.*

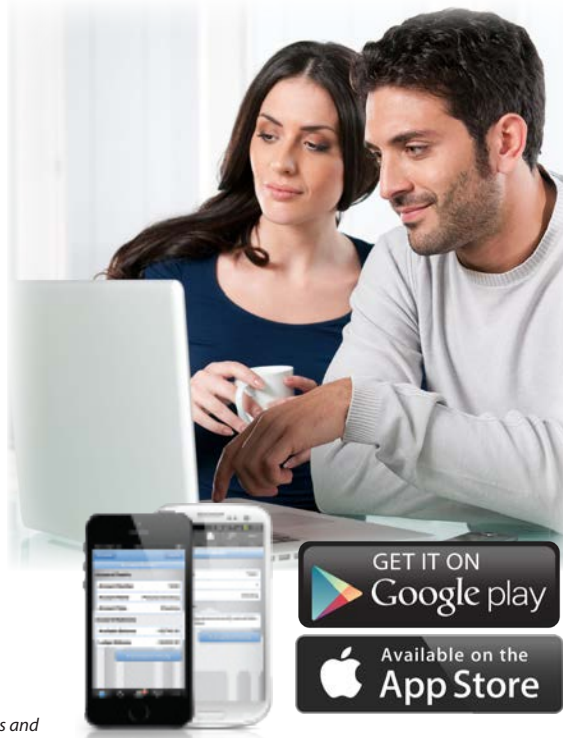
